# POLICY AND RESEARCH INTERN

The intern's primary responsibility will be to assist the Foundation's Policy and Conservation Director with ongoing programs designed to achieve the goals listed below.

Legislative Goals

- Maintain and increase sanctuaries budget and appropriations levels
- Enlarge, expand and strengthen the National Marine Sanctuary System
- Engage on legislation and regulatory actions directly affecting sanctuaries

### Education and Outreach Goals

- Plan and manage Capitol Hill Ocean Week, the premier ocean policy conference held annually in DC (spring internship only)
- Engage and build the National Marine Sanctuary Caucus
- Arrange briefings and meetings promoting sanctuary-related issues and success stories
- Support communities interested in nominating and designating new sanctuaries

<u>Activities</u>: Tasks associated with fulfilling these goals are likely to include researching and analyzing sanctuary-related policies and issues, generating target lists for Congressional and partner engagement, developing and executing an outreach strategy, drafting letters and other communications materials, and planning briefings and meetings with Members of Congress and Congressional Committees, the Administration, and partner entities.
